Mr. Jacunski reported that the roof issues should be resolved by the end of the week. Landscape issues are being addressed and areas have been reseeded.

Discussion and possible action on proposal from CLA Engineers to provide as built drainage structures & inverts, grading, parking, walks, pads and buildings. Also, locate lamps, planters, above ground utilities structures and approx. location of underground services. Zoning issues will not be a part of the survey. Plans will be at 40 scale on 1 sheet, 20 scale on 2 sheets, or 30 scale on 30x42 sheet as desired. Lump sum fee for Oswegatchie as builts \$9,700.00

Mr. Kotait stated that this will be a back charge to Kobyluck if the plans that were submitted by them to BVH were not acceptable. Mr. Wagner expressed concern regarding the proposal's language regarding "zoning issues will not be a part of the survey". The survey is required by the Planning and Zoning Commission and the Commission is "not pleased" that they are not getting the required documentation in a timely manner. Mr. Biega stated that they will be sure that the survey will meet the Town's requirements, and if adjustments need to be made to the proposal by CLA Engineers, it will be done. Any monies expended for this "as built" will be a back charge to Kobyluck and not an additional expense to the project.

X. WATERFORD HIGH SCHOOL

Architect's Report Waterford High School: Jeter, Cook & Jepson

Mr. Smolley stated that they had a very productive meeting with Shane Vallee and the committee regarding the Auditorium. They need to address a possible acoustical shell; however, that will be a part of the FF&E portion of the project and may not be needed. Code review meetings have been held with Hughes Associates and the cafeteria capacity is being worked on. Mr. Smolley stated that they are working on an amendment to the contract for site work. Mr. Brule asked for a copy of the budget for the project. Mr. Smolley asked Mr. Biega to send the proposed construction budget to Mr. Brule.

Construction Manager's Report Waterford High School: O&G

Mr. Biega stated that they had a very good turnout for the pre-bid meeting with approximately 100 bidders attending. There is a lot of interest and a lot of good questions being asked by the bidders. Mr. Kotait is working on the second addenda to send out to the bidders for clarification as a result of their questions. The bid opening date has been set for December 7, 2010. Mrs. Nazarchyk asked if they were required to take the lowest bid. Mrs. Beers explained lowest bid vs. lowest qualified bid and the different variables that can be taken into consideration when awarding the bid. Mr. Biega stated that they are looking at a January, 2011 start for the site portion of the project and March, 2011 start date for the building portion.

Mr. Bill Auwood addressed the Committee regarding the referendum that was held regarding the three schools vs. five schools. He stated that he spoke with a representative of the Secretary of the State's office and was told that in order to change or appeal a referendum, it must go before the Superior Court. Mr. Auwood stated that it was his opinion that the three schools were build illegally. Mr. Wilensky explained that the referendum decision was based on the fact that 20% of the electorate did not vote to overrule the decision of the RTM; therefore, the referendum did not pass. Mr. Wilensky thanked Mr. Auwood for his input.
